Students training to be Elementary Generalists are also trained to be Special Education teachers. We have a postgraduate program called the Urban Teacher Education Program which trains teachers with a focus in the Urban setting. Also, for secondary education program, the required courses cover issues of educational resource accessibility, under-served urban schools, special ed including learning disability, and the related. Since our Unit has implemented SOE Conceptual Framework (nine components including school culture & diversity and professional development), assessment based on rubric per each Conceptual Framework component ensures to train our teacher candidates to be in sufficient knowledge, understanding, and instructional skills (e.g., practice of inclusive education), along with the Conceptual Framework-infused clinical experience at various local schools (urban and rural settings).
